Webinar 1 had its theme **Transitioning the Graduates To Industry 4.0 Workplace (What Educational Institutions have to do to prepare the workforce for industry 4.0?)**. The guest speakers were Rolando J. Paulino, Jr., Managing Director and General Manager, Shell Philippines Exploration B.V.; Dr. Aldrin A. Darilag, CHRP, RMT, RN. Commissioner, Commission on Higher Education; and Jeffrey O. Tarayao, President, One Meralco Foundation.

It was hosted and moderated by Prof. Clarence M. Batan, PhD, Head of the Department of Sociology, University of Santo Tomas. Distinguished guests included Monsignor Bernardo R. Pantin, PC, JCD, President, UST Alumni Priests Association, who gave the Invocation, and Prof. Cheryl Ramos Peralta, DrPH, PTRP, Vice Rector for Academic Affairs, University of Santo Tomas, who gave the opening remarks.

The Summit Overview was given by Assoc. Prof. Jocelyn F. Agcaoili, MHPEd, MSPT, Director, UST GS CCPED. The 3-hour webinar had such an overwhelming response and great feedback, with more than 400 in attendance. It was well received because it addressed the following: the integration of technology, data and human literacies; the yearning for hope in the midst of secularism; the search for truth in the midst of fake news; and, the search for a re-humanized education and meaning in life.

Webinar 2 was also well received with a high number of participants. It followed the theme **Industry 4.0: Disruptions, Disturbances & Disorders** (What are the challenges that Industry 4.0 brings to Higher education?), with Assoc. Prof. Emmanuel D. Batoon, PhD, UST Faculty of Art and Letters, taking the helm as host and moderator. The discussion focused mainly on the COVID-19 pandemic and how it greatly affects the industry and the academe, and how practical and effective solutions can be put in place with the support of the government to help organizations adapt and become resilient and agile.

The Guest Speakers were Tonisito M.C. Umali, Esq., Undersecretary for Legislative Affairs, External Partnerships and Project Management Service of the Department of Education; Rosanna A. ### Collaborative Meeting with the DOST-TOMASInno Center

Last August 11, 2021, the USTAAI led by Dr. Evelyn Songco together with Team Academics led by the Chair, Ida Tionko and the co-Chair Dr. Marilyn Cano, had an initial collaborative meeting with the Head of the DOST-TOMASInno Center, Engr. Raymond Marquez. The meeting began with Engr. Marquez introducing the thrust of the Center and its current state. He discussed the Center as a technology-based incubator (TBI) where innovation is promoted and supported towards commercialization and helps technology-based business start-ups. The center has the capability of providing a range of resources, services and facilities needed during development. As a technology-based incubator, one of the objectives of the Center is to develop entrepreneurs and promote public-private partnerships. They provide assistance related to the business plan and development of a particular product.

The USTAAI, having previously signed a Memorandum of Agreement-Partnership with the University on the Center, discussed at length how partnership and collaboration can be carried out. Engr. Marquez pointed out that at this time, the Center needs help to increase the number of "incubates," mentors, and "inspirers" to the program. Investors are also needed for the full-scale manufacturing of developed products. Admittedly, for these, the Alumni's support is needed. It was agreed upon that the first step to be undertaken is to introduce the Center to the alumni, the faculty and the students in a Webinar. This webinar is scheduled on October 13, 2021 at 5:00 – 7:00 PM. The final plans for this activity will be discussed in a meeting before the said event. – *Ida Tionko, BS Nursing, 1970*

# USTAAI Team Advocacy, UST TALA Donate to Flood Victims

Last July 24, the southwest monsoon, enhanced by Typhoon "Fabian," brought to heavy rains over Metro Manila and Occidental Mindoro, causing heavy flooding in low-lying areas.. In the aftermath of this calamity, USTAAI Team Advocacy and UST TALA organized a flash response to flood victims through the Tomasino Para Sa Kapwa Pilipino project, thanks to the leadership of USTAAI Advocacy chair Engr. Jerenato Alfante and to USTAAI Advocacy co-chair and UST TALA Chair Emeritus Angeli Tuazon.

Volunteers were mobilized and dispatched to give food packs to the affected families in various evacuation sites, namely: on July 25, to Bgy. Masambong and Brgy. Apolonio Samson QC, 300 loaves of Liberty Food bread; on July 26, to Bgy. Burgos Elementary School, in San Mateo, Rizal and Diosdado Macapagal High School in Bgy. Tatalon, 300 loaves of Liberty Food bread and boxes of milk; on July 27, Brgy. San Jose, Rodriguez in Rizal, 105 loaves of Liberty Food bread.


On July 27, USTAAI released a fund amounting

# UST TALA extends help to ARESCOM

7 JULY 2021 - The University of Sto. Tomas Thomasian Alumni Leaders Association (UST TALA) visited the Army Reserve Command (ARESCOM) Training Center in Tanza, Cavite. Spearheaded by Chairman Emeritus Angie Tuazon, the visit was to extend assistance through donations of face masks, face shields, tokens, and gift bags to the Philippine Army Reserve Command frontliners.

The UST TALA volunteer group was welcomed by MGen. Peale Jon Bondoc, Commander of Army Reserve Command, together with Col. Reynaldo Malapad, INF (GSC) PA Governance and Strategy Management Office (GSMO) Head. They received the donations and also gave a tour of the ARESCOM training facilities where the UST TALA volunteers observed exhibitions and training of some of the army. The TALA volunteers also experienced firsthand some of the obstacle courses in the field.

After the gift-giving and the tour, TSg Relita Calapani did an orientation for the UST TALA, and gave a short rundown of the important guidelines on how to become an army reservist.

# **Bridge to Lifelong Learning**

USTAAI's Academic Team continues to provide the university's alumni with topics relevant in today's environment through its weekly online show, Bridges.

July 4, The Blessings of Online Distance Learning. In this episode, Dr. Carina G. Dacanay enumerated the best things that happened to the academic world with the boom of virtual learning. She said that, first, distance learning did not confine learning resources in the four walls of the classroom but it provided infinite spaces for learning and that it opened the possibilities of connecting with resource persons around the globe. The second "blessing," she said, was the use of smart technology for learning, which encouraged teachers to learn and maximize technology to improve student's learning experiences to achieve better learning outcomes. She iterated that more than the technical skills, core values were developed and translated into understanding, support, trust, appreciation, and love. She left the viewers with the final message of gratitude, reminding all that one will never know what blessings are if one doesn't know how to be grateful.

July 11, Urban Farming: Growing our Own Food at Home. *Plantitos* and *plantitas* were once again treated to an interesting topic on hydroponics farming as Emmanuel Alivio, a distinguished UST alumnus, talked about what started as a hobby for him. This hobby grew into a social enterprise, helping other people set up their own urban community farm. The speaker shared his vision of having urban community farms in every barangay, municipality, or city to fill the lack of fresh produce brought about by the pandemic. He also talked about the steps his team is taking to develop the growing community farms. He said that, first, they identify a community and train the people how to start their own urban farms. Next, they look for a location and set-up the farm. Finally, they identify the produce the people want to plant. He emphasized that the most important aspect of all these steps is to ensure the community farm's sustainability from planning, production, and profit. The speaker also shared the basics of how to begin a hydroponics farm. He ended his talk by recommending the viewers to have their own hydroponics garden for personal consumption for healthier living.

July 18, Unsafe in Lockdowns: Child protection against online sexual abuse and exploitation during the pandemic. Discussing this very serious topic was Atty. Alexandrino Mallillin. Atty. Mallillin works for the International Justice Mission (IJM), the largest anti-modern-day slavery organization in the world based in Washington, D.C. It has field offices in Manila and Cebu, where they focus on online sexual exploitation of children (OSEC). Atty. Alex explained what acts are considered OSEC and how these crimes increased during the pandemic. While the Philippines is the epicenter of such crimes, it is also at the forefront in the fight against cybersex trafficking. He cited the study done by the National Center for Missing and Exploited Children (NCMEC) that said that there has been a 28% increase in incidents, from 16.9 M reported in 2019 to 21.7 M in 2020. He mentioned that due to the hardships encountered during the pandemic, it is the children's own parents who are perpetuating these crimes. He explained that since OSEC is a global crime, it thus requires a global response and since it is a technological-enabled crime, it needs a technology-enabled solution. He added that social media is the most commonly used platform as it is also the most accessible by anyone around the world. He mentioned that last year, the Philippine Internet Crimes Against Children Center (PICACC), an interagency collaboration, conducted 79 law enforcement operations, rescued or safeguarded 231 victims, and arrested 41. A video of a survivor of child trafficking was shown where the victim showed her resilience despite the trauma she experienced at a young age, proving that the past should not define one's future; the experiences even served as an example of restoration and healing. In conclusion, Atty. Mallillin reminded the viewers to be vigilant about what they see in social media platforms, to join the fight against human trafficking and to report any cybercrimes, especially child trafficking.

**July 25**, Draw and Write your Stress Away. Dr. Sheila "Shake" Marie G. Hocson started the discussion by saying that stress is like a pressure cooker, that if one has already too much on his/her plate and doesn't know which one to prioritize, stress can happen and that when stress already affects our day-to-day life, then it is something alarming. She further discussed how stress can affect a person's behavior, affect, soma, and cognition and that negative thoughts also add to stress, so it is very important to have people one can talk to and lean on, to help him/her identify whether his/her worries are valid or just exaggerated in the head. Dr. Shake also introduced a new study on digital citizenship and well-being, where technology is not necessarily an effective way to reduce stress because social media is a double-edged sword in the sense that it can be used as a positive and negative influence. So instead of using digital apps or mobile games, Dr. Shake recommended drawing and journaling that can be a catharsis to reduce one's tension and release pent-up emotions. According to her, some of the benefits of creative and expressive arts are that it creates a safe space, which calms a person down and it gives hope and peace of mind. She added that it helps one process thoughts, identifies the pros and cons of one's actions, and most importantly, it provides one with self-insight. In writing, those with mental health concerns should not write down anything that triggers them negatively. The speaker also shared several structured activities like using vision boards, graphing feelings, and identifying sources of strength. Dr. Shake ended her talk with the message that our strength is inherent and it starts with a good mind, heart, and actions.

**August 1**, Yaman ng Ating Lahi at Kultura. The guest speaker, Joey Omila, shared with us his story on how he spread Philippine culture around the world. He shared that despite living in the US for several years, he hasn't forgotten his Filipino roots. He found a deep love for our culture, from the Tibolis and Manobos of Cotabato, to the Sinulog of Cebu up to the time he became one of the pioneers of UST's Salinggawi Dance Troupe. He also shared how people from around the world appreciate our culture and rich history through dance, fashion, and other forms of art. Mr. Omila also described the various exhibits that they display in the Bayanihan Center, popular among schools and in events, bringing a little bit of the Philippines to America. He urged the audience to be proud of being Filipinos, of our traditions and culture.

August 8, Wacky Wika, Alien! This was an episode filled with laughter as our guest speaker, Herman Salvador, more popularly known as Brod. Pete, talked about the topic. The episode started with the speaker talking about how he got his moniker Brod. Pete, jokingly saying that he looked like the Hollywood actor Brad Pitt. Despite the pandemic, Brod Pete emphasized the importance of laughter and that only people have the gift to laugh. He further said not to take things too seriously. Then he discussed about his passion for comedy, and how he wanted to share how he also wanted others to laugh. He shared that how to make people laugh is to connect with them, to know them and their language. There is no such thing as an expert in comedy and comedians should keep learning. One should also absorb as much information around him and to keep updated, and focus on the funny side of everything. Comedy is not as simple as it seems, because it involves various disciplines such as psychology and sociology. He explained how he wrote comedy for other people and how powerful a tool language is, which can be used for good or bad. He further elaborated that language should be used as a medium of instruction, stating that effective communication doesn't cover correct grammar, but more importantly, if the message is clearly received and understood. A short video, with him as one of the actors, also provided as an example of how language can be used how to present a serious topic in a lighthearted way, but remaining very informative. He advised people who want to be comedy writers to really make sure they have a passion for it, to study and research, and to keep working on their craft. Throughout his talk, Brod. Pete has proven he has not lost his comedic

August 24, What it takes to be an Olympian: Mindset, Experiences, Struggles, and Success. This was a very timely episode as it aired just after the country won a first 2020 Olympics gold medal, courtesy of Ms. Hidilyn Diaz. The guest speaker, Dr. Karen Trinidad is part of Team HD, as a sports psychologist. She shared with the viewers Hidilyn's journey to the Olympics, as well as how important every member of the team is crucial to cover all the needs of an athlete. Dr. Karen discussed how an athlete's success in sports no longer lies in luck, but more on science, and that how an individual performs in sports is now a combination of physical preparation, technical skills, and psychological readiness. She also discussed the different attributes, focusing on the psychological attributes such as, confidence, concentration, consistency, and control; and neglecting any of the four can interfere with an athlete's performance. The stories behind the scenes that Dr. Karen shared proved that being an Olympian is now a holistic preparation. To wrap up her discussion, Dr. Karen thanked Hidilyn for shedding light on the importance of sports psychology to athletes and welcomed more people who are interested in this field to be able to breed more award-winning Olympians in the future.

August 31, And There Shall Be Heroes. Historian-guest Dr. Jose Victor Torres talked about what it really takes to be a hero, sharing how he compartmentalizes writing history and plays, and it is his ambition to combine both. He considers writing history as non-fiction but still a literary product, where he writes history like a story, explaining the term "kasaysayan." He discussed the concept of a hero through the eyes of a writer as one who can sacrifice things he loves and values to spread dignity to others. According to him, heroes can change depending on the situation, just like the heroes during the pandemic; they are those who sacrifice their life for the health and safety of others. Further, he reminded everyone that heroes are just ordinary people with weaknesses and flaws, but who have done something extraordinary. Dr. Torres also said that the first part of being a hero is conquering one's fear, because one has to conquer himself first.


Meer; Team Public Presence by Mr. John Peran; and the Secretariat by its Chair, Ms. Nanette Fernandez.





The UST Law Alumni Foundation, Inc. (UST LAFI), now headed by Atty. Maria Elena Go Francisco, has always been true to its mandate to promote, organize and conduct projects and programs for a more effective exchange of information among alumni, among which is the sponsorship of scholarships for deserving law students of the Faculty but are financially challenged. For the past several years, the UST LAFI offered fullyfunded scholarships and had, in fact, produced numerous scholar-graduates.

This year, the Foundation's Board offered to this writer the Chairmanship of the Committee on Scholarship. After accepting the offer, I

immediately thought of ways on how to foster closer relations between the alumni and students. Emboldened by my belief in the capability and competence of the Thomasian, I suggested to make the scholarship available exclusively to Thomasian undergraduates. To my mind, the proposal would be a good incentive for the University's finest graduates who are planning to pursue a law degree to consider the Faculty as their primordial choice. The ultimate goal, of course, is for the Foundation to be able to choose the best qualified students who could best represent the core Thomasian values of competence, commitment and compassion.

The suggestion to limit the applicants to Thomasian undergraduates opened up an academic and, at times, animated discussion on the matter. Limiting the scholarship to Thomasian graduates would, indeed, deprive the Faculty of brilliant graduates from other schools. However, with much persistence and resolve, I was able to eventually convince the Board that making the scholarship exclusive to Thomasians could - in the long run - help the University retain its own 'bright minds. Indeed, making Thomasians a priority - especially during this pandemic -would be a noble and practical idea considering that the Foundation's funds are pooled mainly from the generous contributions and resources of Thomasian alumni.

In formulating the guidelines for evaluating scholarship applications, the Committee wanted to emphasize competence and exemplary academic performance. As such, the Committee incorporated into the Guidelines the allocation of corresponding points for those with Latin honors, as well as those who excelled academically during their undergraduate studies.

As an added incentive, the Committee also put points to applicants with a history of Thomasian education in their family. In order to additionally gauge the qualification of the applicants vis-à-vis their character and values, qualifying written exams and interviews were set, with the corresponding percentile depending on the applicants' performance on these exams. For clarity, the criteria – which were shown to the applicants – are as follows:

The Announcement posted in the University's website in the first week of August essentially stated that the Foundation "will award scholarships to five (5) highly qualified candidates for the 2021-2022 academic school year" and that they would be entitled to full or partial discount on tuition and miscellaneous expenses, book allowance and monthly stipend. It enumerated the following eligibilities: (a) open to Thomasian undergraduates in any field of study; (b) must be an incoming freshman enrolling in the Faculty of Civil Law by the start of the academic year; and (c) must be enrolling for the first time in law school.

Twelve applicants submitted their requirements. It is surprising to note that some of the

applicants were not incoming freshmen, but incoming third year and fourth year students who wished to avail of the scholarship due to financial struggles brought about by the current pandemic. Notably, all twelve applicants possessed impressive academic credentials: most were recipient of Latin honors, and a few already even passed the Board exams of their respective undergraduate courses.

The qualifying exam, administered on August 7, 2021, consisted of 36 questions and had a time limit of three hours. The questions were meant to gauge the applicants' ability to express themselves in writing, think critically, make judgments based on premises, and make choices based on circumstances.

The applicants then had written interviews before a 30-minute online interview conducted on August 15, 2021. The questions in the interview covered a wide range of topics, but emphasized mainly on why they are applying for a scholarship, why they are choosing UST over other schools, how they could be an asset to the University, and how they could give back to their alma matter. The Committee also made follow up questions on their written answers and asked them to expound on some answers.

After a meticulous process, the Committee eventually chose seven (7) applicants to be the LAFI's scholars for the school year, namely:

- Marc Angelo Galvez Santos; (Magna Cum Laude, BS Accountancy; No.5 CPA Board)
- 2. Ianna Nicole Basilio Lucas; (Cum Laude, BS Accountancy)
- 3. Mikaela Gabrielle Estalilla Fernandez; (Magna Cum Laude, AB Communication Arts)
- 4. Sophia Marionne Soliman Salonga; (Cum Laude, AB Behavioral Science)
- 5. Alaiza Agatep Adviento; (Magna Cum Laude, BS Accountancy)
- Kirby Anne Cesario Renia;(Cum Laude, AB Political Science) and
- 7. Ellaine Denice Hermogeno Marallag (Dean's Lister, AB History)

The final interview, also done online, was held last August 19, 2021. In this meeting, the scholars were informed that they should be able to maintain a quotient point index (QPI) of 85% to keep their scholarship. The Committee purposely set a high standard in order to ensure that the Foundation's scholars will make their law studies their utmost priority. The selection process was indeed time-consuming but a necessary one if the Committee were to select the best and most qualified (i.e., 'cream of the crop') applicants who will best manifest the core values and ideals of the University.

This is the Foundation's own way of helping Dean Nilo T. Divina in his quest to have the UST Faculty of Civil Law regain its former glory. To be sure, the groundwork had already been laid as evidenced by the remarkable passing rate of the Faculty in the Bar Examinations during the past several years, highlighted by three topnotchers in both the 2017 and 2019 Bar Exams.

Truth be told, this writer was initially hesitant to accept the designation to be the Chairperson of the Committee. However, after the scholars had been selected, he could honestly say that the whole process brought personal fulfilment. Hearing the stories and struggles of the applicants and witnessing their dedication and commitment to achieve their dreams was truly a gratifying moment. Gratitude is extended to the Foundation for the trust, opportunity and experience.

Gratitude is equally extended to the other members of the Committee - Atty. Frankie Magsalin III and Atty. Joseph Cerezo for their invaluable assistance and insights. Through discussions and differences in ideas, everyone worked in unison towards our goal to lend a helping hand to our fellow Thomasians. # **AB IS NOW BA**

The Faculty of Arts & Letters and its programs are now referred to as Bachelor of Arts or BA.

Prior to the previous academic year, these programs were called AB, like AB Journalism or AB Mass Communications, and the Faculty itself was more popularly known as AB rather than Arts & Letters. Then, the students would say "AB" while students of the College of Education referred to their faculty or program as "Educ" and those from the Faculty of Engineering, "Eng."

According to Dean Marilu Madrunio, the change was for "consistency purposes and to align the nomenclature with the programs offered in offshore universities." The abbreviation AB stands for "artium baccalaureus," the Latin term for Bachelor of Arts or BA. Dean Madrunio further explained, "This BA degree, which is a liberal arts program, puts emphasis on the humanities and social sciences. In the sciences, the Latin name for the degree is "scientiae baccalaureus" or SB. Since the programs in Science follow the abbreviation BS, it would be better to call our programs BA for purposes of consistency."

The Faculty now offers 13 majors or programs. These are: BA Philosophy and BA Literature, both recognized by the Commission of Higher Education (CHED) as Center of Excellence; BA Literature, BA Communication and BA Journalism, Center of Development; BA Asian Studies; BA Behavioral Science; BA Economics; BA Legal Management; BA Political Science and BA Sociology. BA in History and BA in English Language Studies were established in 2011 and BA in Creative Writing, in 2018.

It will be a culture change for the UST student population, and perhaps the stakeholders, to adopt the habit of calling the Faculty and the programs as BA. While in the previous years, the answer to "What college are you from" was "AB," it may now be "BA," unless the change moves to "Arts & Letters." – Joy Viray-Gatmaytan, AB Translations, 1980.

Apart from Program-led activities, the Faculty of Arts and Letters administration will also run the

following activities, namely: Academic lectures of faculty who recently completed their PhD Degrees in offshore universities; The Teodoro Valencia Professorial Chair in Journalism Lecture and The Fr. Valentin Marin, OP Professorial Chair in Communications, both in partnership with the Secretary-General's Office; The St. Thomas More Lecture; and Special Recognition Honoring AB's past Deans and regents.

### Artlets Batch 1969 Quasquicentennial Competency Legacy Project

The Faculty of Arts and Letters batch 1969 reuniting after fifty (50) years drew nostalgia among batch members to look back at their cherished UST memories. Armed with their collective stories of success working in different fields and industries such as social work, advertising, education, politics, journalism, entrepreneurship, banking, among others, the class decided to do something valuable and impactful but different from typical ways of raising funds.

This gave birth to the conduct of **Competency Identification Mapping Project** designed and implemented by 1969 batchmates Eyra Lourdes Umali, Economics graduate, and Tita Datu-Puangco, Literature major in Journalism graduate, as the batch's legacy project contribution in line with AB's Quasquicentennial celebration.

The Competency Inventory is envisioned to be integrated into the curriculum or leadership development initiatives programs thereby facilitating more purposive career planning efforts for and by the graduates. The projects support the strategic thrusts of Dean Madrunio and the Quality Management System or QMS campaign program of the University wherein competency-based learning and developmental program is a QMS requirement.

The following core competencies were culled from the sharing of life stories of batch 1969, validated and assessed through five batches of Focused Group Discussions (FGDs), namely: AB admin, non-teaching staff, faculty, student leaders and alumni.

The identified Core Competencies are anchored on the following: Value-based self-leadership; Quality orientation; Communication skills (English) and relevant local languages; Big picture thinking; Innovation; Service orientation; Ecosystems thinking; Love of country; Managing



change; Integrity; Managing capability; Information technology skills; Passion for work; Problem solving and decision making; Leading performance; Events management; and Learning and development.

The AB Competency Mapping Identification Inventory Study will be launched on November 20, 2021.

#### "Adopt an Artlets" Scholarship Fund (AASF)

Like other Filipinos, students in the faculty of Arts and Letters have had to struggle to meet the financial needs of going to school given the bleak pandemic environment. The Faculty is experiencing a marked increase in the number of students filing for a leave of absence (LOA), an indicator of financial hardship.

As a matter of solidarity, the AB Alumni Core Group, sees the need to provide financial support to students who are unable to continue their studies due to the prevailing economic circumstances occasioned largely by the pandemic.

AASF is headed by Oscar Picazo, Economics graduate of batch 1978. The principles, nature, scope of AASF are the following: Solidarity, Inclusivity and Participation; Formal Organization and Management; Transparency and Integrity; and Sustainability and Fairness.

The possible sources of funding for AASF are expected to come from alumni individual contributions, corporate contributions, class or batch group contributions, specific endowments or trust funds.

AASF will also be launched on November 20, 2021

Tropics (CCPET), was the guest for this episode. He talked substantially about "Heritage Conservation," and expounded specifically on the topic of cultural mapping which is "a mode of inquiry and a methodological tool that aims to make visible the ways local stories, practices, relationships, memories and rituals constitute places as meaningful locations." In essence, according to Dr. Zerrudo, cultural mapping is a method to identify the heritage of the place, or to pinpoint what the place already has in terms of its basic resources, and likewise its material and non-material culture. In line with this, several Local Government Units in the country, like Samar, Leyte and Iloilo, among others, have availed of the services of Dr. Zerrudo and his team from the Graduate School regarding cultural mapping.

September 14, "Together, We Can Save Lives." Episode 45 featured the "Hospital on Wheels" (HOW) with Dr. Juan "Jim" Sanchez, its founder and CEO, as guest. Dr. Sanchez is a TOTAL awardee, a two-time CNN Hero nominee and multi-awarded for his professional and community services. The HOW was born with Dr. Jim's strong desire to help others and for community service and to help address the country's health needs. With the help of committed sponsors and organizations. HOW has conducted more than 280 medical and surgical missions all over the Philippines, mostly in Luzon, from the time it was launch in September 17, 2007 to March 15, 2020 before the Covid-19 pandemic. Dr. Jim shared that his team of volunteer doctors, nurses and other health team members has served more than 18,000 surgical patients, 400,000 medical patients, 10,000 dental patients and 10,000 optical patients. The patients were also provided free medicines and free reading glasses as needed. Along with these missions, HOW has also provided education and training to doctors, nurses and other health professionals through lectures, seminars and on-the-job training during the missions. This is what Dr. Jim has dedicated his life for and he said that this is where he found his meaning and purpose. The pandemic has not deterred the HOW in continuing its mission. Charity surgeries continue at Dr. Jim's Surgical Center in Quezon City. The HOW has even opened further its community service to the Healthy Lugaw on Wheels (HELOW) Feeding Program. His team has a newly-acquired a minivan customized for the weekly feeding program, serving porridge with boiled eggs in depressed areas in Montalban, San Mateo, Quezon City, Manila and Caloocan. Dr. Jim has also set up the Home Management Program for COVID-19, a First Aid Call Center and Emergency Medical Service to help address the overwhelmed health care system for families and people afflicted with this illness. With the very encouraging contribution the HOW has done for the health of the people, Dr. Sanchez said that he has a big plan to build a prototype of the HOW Mission Hospital in every region of our country. Indeed, the fire in the heart of this compassionate Thomasian doctor is inextinguishable - to serve and help improve people's lives.

Manila Gas Corporation, at which time he was able to resolve with success the labor disputes there. In 1980, he joined one of the famous law firms at that time: the Sabido, Sabido, & Associates (Sen. Pedro Sabido & Cong. Roberto Sabido). Because of his skill and exposure to labor relations, (aside from being as Associate Lawyer), he was appointed to an additional position of Industrial Relations Manager of both the Sabido, Sabido & Associates, and The Manila Gas Corporation. At age 36 when his boss Atty. Robert Sabido passed on, he applied and was hired as Human Resources Manager of Bacnotan Cement Company owned by PHINMA, a group of companies. He was about to leave for La Union when his former bosses at the Manila Gas Corporation invited him to come back, offering him the same salary and benefits as PHINMA's.

In 1984, he assumed these positions in Manila Gas Group of Corporations: Admin & Legal Manager, Corporate Board Secretary, and Secretary of the Executive Committee. In 1986, Atty. Jack was promoted to Group Manager with the rank of Vice President, overseeing the Administrative, Legal, and Purchasing Departments.

Going back to law practice, however, has been consuming him for quite some time, so that in 1986, he founded a law firm with two Thomasian lawyers and one Atenean lawyer: Castaneda Macaraeg Angeles & Francisco Law Firm. In 1993, however, Atty. Jack was appointed by President Fidel Ramos as Commissioner of the Energy Regulatory Board - which position he held with diligence, commitment, competence, and compassion (Thomasian Core Values) up to 1997. From 1999 to 2004, he was with the law firm GAVEC LLB. In the year 2000, he was elected as a member of the Board of Directors of the Integrated Bar Of The Philippines (IBP), Pangasinan Chapter.

At present, Atty. Jack is with his Atenean law partner, Atty. Redemberto Villanueva, in the RRV Legal Consultancy.

In his lighter moments, Atty. Jack confesses that he enjoys doing some "Apostolic work "(when needed) with his five grandchildren. His first marriage did not last long, however, when Sonia succumbed to an ailment. He had a second nuptial with a fellow Thomasian Lawyer, Atty. Maria Teresa Ramirez (Terry, UST Law, 1991), with whom he has one child – Marrion (23 years old), now in her second year law proper at the UP College of Law.

His children with Sonia are: Vincent - lives and works in Australia with his wife and 3 daughters; Edward Jr. - lives and works in Manteca City, California USA, with his wife and 1 son; Clare Anne - works at San Miguel Corporation, has 1 son.

His advice to young lawyers and students of Law: "Continue studying even during these times. New opportunities in the New Normal may come your way; don't panic. Law remains as the noblest of all professions. Under all systems in the world, lawyers are always needed not only to litigate cases or to render legal opinions. Legal issues such as "Who is at fault?", "Who was deprived of his rights and entitled to restitution?" are areas where only lawyers can be retained to do their task.
