The UST Alumni Association, Inc. (USTAAI) and the Thomasian Alumni Legal Assistance Bureau (TALAB) has started providing notarial services since January 8, 2024. This service is available to all alumni, students, academic and administrative staff of UST at a reduced cost. USTAAI, which has long been committed to giving back to the university, sees the potential of TALAB in offering the convenience of notary services on campus to the Thomasian community. Since January, majority of the documents notarized included parental consents and student undertakings.

The USTAAI-TALAB notary service is available from 2PM to 5PM, Monday to Friday (except holidays) at the USTAAI office, Room 322, UST Buenaventura Garcia Paredes, O.P. Building (BGPOP). Those availing of this service are advised to bring at least 2 copies of the document to be notarized, originally signed by the parties (wet signature, not electronic), and a photocopy (back & front) of a valid government ID with picture, signed 3 times along the margins. For parental consent and student undertaking, a photocopy of a valid government ID of the student and the parent or guardian is required.

## FROM THE PRESIDENT'S DESK: At Your Service by Atty. Dwight Ramos

## REHOMING....

or those with pets, rehoming is a familiar word. Even more so for those who have experienced trouble with their pets and have thought about parting with them just like me. During the pandemic, our family decided to take in a pet dog as we were struggling with being confined to our home during the lockdowns. School and work were done purely online and so Max, in all his cuteness, was a welcome addition to the family, providing respite from the new daily grind that each one of us faced. We were oblivious of the warnings about his size and breed that reputedly were hard to handle. And so, for the whole of the pandemic years and even after, Max was the household favorite even earning the monicker as the "One Spoiled Dog" even if he actually looked like a bear. He virtually owned the house, running everywhere and being in any room he wanted to sleep in at any given time. None of us minded, especially after the pandemic when our family members started going out and we thought of Max as now the perfect guard dog.

Yes, he was quite territorial which was why we no longer accepted visitors at home. However, he bit one of our relatives when she tried to touch his water bowl. My son and daughter also got bitten, but we continued to adore him. We would jokingly say that he owned us instead of the other way around.

While I was walking him one day, he got agitated and attacked the friends of my daughter who

were walking near us. When I prevented him, he suddenly turned to me and bit me. Worse, I stumbled and hit my head on the ground so I immediately rushed to the hospital. Good thing that except for the bite, I was alright. That night, he was easily forgiven and things immediately went back to normal.

The day after, he walked up to me to be petted which I did. When I stopped, he apparently wanted more and got so agitated that he tried to bite me again. This time, I escaped and we locked him up in the garage.

We would learn later that he became so spoiled that he now would bite even us anytime he did not get what he wanted. Fearing for our safety, I already contracted the City Pound to get him the next day. But my wife and children intervened. Instead, we contacted a dog training school to discipline him. So, we decided to give it a chance, but after almost a month, we were ready to give up because he remained aggressive. But, we extended his stay but already started contemplating about rehoming him. The practice is prevalent abroad but it seemed there are no such facilities here. So, some pet owners would just ask relatives in the province if they could accept and take care of their pets on their behalf.

In the meantime, we got to learn from the dog trainer that most of Max's bad attitude was a result of our inability to discipline him and of the environment which we provided. In short, it was our fault for spoiling him. That he was just being a dog and we were





actually confusing him with our mixed messages by rewarding bad behavior and not reinforcing good ones.


It was at this point that we realized that the rehoming we needed was a change in our home environment suitable for responsible pet ownership. We built a cage for Max, but more importantly, we built a new nurturing but disciplined home environment for him as we finally welcomed him to our house again.

So now I am thinking that perhaps, similar to some of our situations in life when we feel like kicking out a trouble maker or even escaping our very own home, office or school for a better place, there might not really be a need to do that. It would be good to see if the problem may lie in adjusting instead how we treat and deal with each other...a change in relationship dynamics might just be the key!



Atty Ma. Elena R. Enriquez, the Corporate Secretary of USTAAI, showed the AA secretaries how to -

1. Navigate the SEC website so that they could view

the documents that they have filed and request for copies if needed;

- 2. Comply with SEC Memorandum 28, which is the requirement to inform the SEC regarding the primary and alternate email address and mobile numbers of their respective alumni associations; and
- 3. Register with the SEC electronic filing and submission tool (eFast) where they will file their annual mandatory reports such as the General Information Sheet (GIS) and Audited Financial

Statement (AFS) as well as the NSPO forms that are supposed to be attached to it;

The group also went over the format of the GIS, particularly the page on beneficial ownership, and the deadline for uploading the report to eFast. On the whole, this initial meeting was productive. The group created a Messenger thread so that they could stay in touch with one another, exchange information, and extend assistance whenever needed.

Team Medicine & Surgery receives the championship trophy

he sixth edition of the Rector's Cup: Thomasian Alumni Golf Tournament raised over 3 million pesos for the benefit of Thomasian student-athletes. The proceeds were turned over to the Institute of Physical Education and Athletics (IPEA) on March 18, 2024 at the George S.K. Ty Hall at the Buenaventura Garcia Paredes, O.P. Building (Thomasian Alumni Center). The funds support critical areas in need of development programs for the student-athletes who compete in national and international sports events.

Rector's Cup Tournament Director Dr. Adrian Laurel said the tournament, held on February 12, drew 280 golfers which is the largest player turnout throughout the project's run. It is a large leap compared to its player population since its establishment in 2016. The tournament has been consistently recruiting more alumni and supporters every year.

"You bear the logo and name of UST at the front of your uniform and your surname at the back. You represent the university. Always remember that there is a strong alumni [community] behind you,"

he said, assuring the student-athletes of the community's continued support during his inspirational speech.

Thomasian Alumni Community Foundation, Inc. (TACFI) Chairman and Rector's Cup head pioneer Dr. Robert Sy also reported the financial history of the tournament. Since its inception, the Rector's Cup has been able to garner and turn over 18 million pesos of donations to IPEA. He looks forward to the unending commitment of the project to its beneficiaries.

"You are all this is all about... And to the next generation of athletes," said Dr. Sy before he ended his message.

Over 10 college-based teams joined this year's tournament which includes College of Accountancy, College of Architecture, Faculty of Arts & Letters, Faculty of Civil Law, College of Commerce & Business Administration, Faculty of Engineering, Junior High School, Faculty of Medicine & Surgery, Faculty of Pharmacy, and the College of Science. Guests and

friends from different industries also participated in solidarity with the tournament's advocacy.

For this year, Team Medicine & Surgery clinched their 3rd straight championship followed by Team Pharmacy in second place and Team Engineering for the third place.

#### BRIDGES KICKS-OFF 2024 WITH ENVIRONMENTAL TOPICS

fter last year's Christmas holiday break, BRIDGES resumed with back-to-back topics tackling environmental issues, beginning with "The Plastics Era: Boon or Bane" on 16 January 2024. Guest Dr. Joseph Ross S. Jocson, MNSA, Commissioner of the National Solid Waste Management Commission and president of the Asian Packaging Federation, shared the benefits and challenges in plastic waste reduction, and the need for an urgent local, national, and global response. On January 23, Engr. Sherwin B. Valeroso, Supervising Environmental Management Specialist of the General Trias City Environment and Natural Resources Office (CENRO), took the guest seat during the episode "Sustainability & Climate Change: When It Is All Greek To Us" to discuss climate change and how governments, companies, and the public can contribute to the creation of sustainable solutions and the necessary actions to curb its worst impacts. Bridges capped its January line-up of shows with the episode titled "Usapang Innovation at Start-ups", featuring Mr. Jonald Justine Itugot, Founder and CEO of Cerebro and TOMASInno Center (TIC) Incubation graduate, who tackled the role of start-ups in innovation, and vice versa, and how to introduce products to the market that enhance value for customers. Sponsored by TIC, this episode was hosted by Mr. Claude Despabiladeras and TIC Assistant Manager Engr. Celso Noel Aban, MEntrep, who encouraged the guest to give his insights on the role of TIC as a leading Technology Business Incubator (TBI) in the Philippines and as UST's hub for innovation and technopreneurship.

On February 6, in the episode "The Office of Alumni Relations (OAR): Nurturing the Thomasian Alumni Community", Asst. Prof. Joreen T. Rocamora, PhD, newly appointed Acting Director, gave her vision and plans for OAR under her leadership anchored on its mission of establishing and enhancing a continuing relationship between the University and its alumni, and the collaboration efforts between USTAAI and OAR. For the Valentine's Day episode "Must Love Earth: My Perfect Valentine", Dr. Arlen A. Ancheta, faculty member of the UST Faculty of Arts and Letters and Sustainability Studies Academic Researcher of the Research Center for Social Sciences and Education (RCSSED), delved into reigniting the passion for the environment and discussed ways we can help to create a more sustainable future for our planet. Bridges continued its February's theme about love with the episode "Love Means ..." on February 20, bringing into the forefront the story of a husband and wife and their challenging journey of having a child on the autism spectrum. Architects Victor and Catherine Cham shared how their love and acceptance helped nurture their son to grow up and to develop his gifts and talents to become more independent. Towards the end of the show, in a heart-warming family moment, both parents allowed their son Vico to talk on camera to share his achievements as a young and exceptional creative artist, to show his artworks, and to personally thank his parents for their unconditional love and support. "Lent, Love & Life", aired on February 27, featuring Mr. Raymond Daniel "Jun" H. Cruz, Jr., former president of the LAIKO (Council of the Laity of the Philippines), as guest. This episode looked into the many different ways of how Lent is



celebrated, to allow the viewers to have a meaningful season of reflection refocusing on Jesus' journey to the cross, His resurrection and the purpose and meaning behind His ministry.

In March, the UST Atelier Alumni Association, Inc. sponsored two consecutive shows of Bridges. Starting with the episode "Kalansing ng Pera at Medalya", Mr. Paul C. Balan, sat on the guest seat on March 5 and shared his life story and journey as an artist, which culminated in his success in designing coins and medals. His craft led him to be recognized worldwide, winning numerous awards, becoming the first Filipino and first Asian U.S. mint and commemorative coin designer. In a break from the usual zoom livestream, this episode was recorded onsite at the UST Thomasian Alumni Center, with both the guest and the host (Mr. Janos Delacruz) sitting side by side during the interview. This episode was followed by "Manlililok: Apoy at Bakal" on March 12, which featured the modern and contemporary artist Richard Buxani, an Imus-based sculptor with a degree of BS Architecture from UST. This show delved into the art of metal sculpting, with Buxani sharing his bend and weld method in creating his sculptural works, integrating pop art, religious icons, and architectural know-how to achieve his style. In celebration of Women's Month, Bridges invited Ms. Visitacion Asiddao as its guest on March 19 to give insights on how women have made significant progress in recent decades towards equality, recognition, and respect. In this episode titled "Women as Ambassadors of Cultural Understanding and Unity", Ms. Asiddao, a 40-year veteran of the Department of Foreign Affairs and an attaché at the Philippine Permanent Mission to the United Nations in Geneva, shared the challenges and opportunities of being a diplomat, and her

experiences and contributions to the diplomatic missions around the world.

Bridges capped this year's first quarter with a total of 10 episodes, with Dr. Evelyn A. Songco, Atty. Dwight M. Ramos, Mr. Gene Kenneth M. Ilagan, Ms. Thelma S. Marana, and Dr. Evangeline E. Timbang sharing hosting duties. Now on its 4th season, BRIDGES has significantly increased its viewership last year, up by about 30% compared to 2022.

BRIDGES reached its 4th milestone when it celebrated its 3rd anniversary during the 128th episode, titled "Mental Health, and why you should care," on October 3, 2023. The show tackled the mental health issues affecting millions of people across the globe, with featured guest, Ms. Michelle Rose Yabut-Cornes, MA, RGC, a Registered Guidance Counselor at the UST Counseling and Career Center. Since its initial launch in 2020, BRIDGES has produced 148 episodes. As with the previous year, the USTAAI member alumni associations will take turns this year in sponsoring the episodes of BRIDGES, providing the guests and the topics for discussion. Last year alone, 53 notable Thomasian alumni have graced the show as guests, with a total of 43 alumni sharing the limelight while performing excellent hosting duties, showing their passion and keenness especially when challenged with serious and thought-provoking topics.

#### ARTLETS ALUMNUS BAGS NATIONAL AWARD FOR PH IN GLOBAL PHOTOGRAPHY

A N ALUMNUS of the UST Faculty of Arts and Letters (AB) has emerged as the National Award winner for the Philippines at the 17th Sony World Photography Awards. Reginald James Lorico, a legal management graduate from batch 2013, won the gold in the open competition category for his entry depicting a sunlit building in Tehran, Iran.

Lorico said the image's focal point took inspiration from the monolith in the 1968 film, "2001: A Space Odyssey."

According to him, UST paved the way for his dedication to photography both as a hobby and professional endeavor.

"[I]t was during my time as a student of our [U]niversity when I developed my love for photography thanks to the help of Thomasian student photographers such as Paul Quiambao among others," Lorico said in an email to **The Flame**.

Lorico attributed his pursuit of photography to his Artlets friends who made significant contributions to his growing interest in the craft when he was still a student in AB.

"At the time, I did not have any camera gear of my own but it did not stop me from learning the craft since my friends would lend me their gear and even take me to events around Manila where I could practice it," the UST alumnus said.

"Every success I achieve in this field can always be traced back to my time at our alma mater," he added. A native of Eastern Samar, Lorico also took pride in his hometown, saying the award is a "testament to the ability" of the Borongan locals.

"They can dream big and share the stage with the best in the country and even the world," he said.

The award-winning photographer has received accolades from several photography competitions, including the Nikon Club Philippines where he ranked first place in the photo of the month (August) category in 2014; the Aigle Philippines Outdoor Photography Contest in 2017; and the #OishiASEANJP Campaign, ASEAN-Japan Centre where he came in first place last year.

The Sony World Photography Awards received nearly 400,000 submissions from more than 220 countries and territories worldwide.

The 54 countries that emerged as winners of the National and Regional Awards will receive a Sony digital imaging equipment. The winning entries will be displayed in an exhibition at Somerset House in London from April 19 to May 6.

All winners in the student, youth, open and professional contest will be revealed on April 18.

Launched in 2007, the Sony World Photography Awards is a globally renowned photography competition which champions both established and emerging artists with the most notable contemporary photographs around the world.
